**WHEREAS**, it is deemed to be in the public interest to accept Change Order No. 1; and

**WHEREAS**, the Borough Engineer, Laurence Plevier, P.E., C.M.E. (Hatch Mott MacDonald) has, by letter dated December 7, 2009, (Exhibit "A", attached) recommended the execution of Change Order No. 1 which added to an overall increase of the total cost of the project by \$2,795.66.

**WHEREAS**, due to the need for an adjustment for the difference between actual cost of Traffic Control provided by the Borough of Mantoloking Police and the Contract Allowance as per Information for Bidders Section 0.34 Allowances of the Contract Documents, S. Brothers, Inc. has submitted Change Order No. 2; and

**WHEREAS**, it is deemed to be in the public interest to accept Change Order No. 2; and

**WHEREAS**, the Borough Engineer, Laurence Plevier, P.E., C.M.E. (Hatch Mott MacDonald) has, by letter dated December 14, 2009, (Exhibit "B", attached) recommended the execution of Change Order No. 1 which added to an overall increase of the total cost of the project by \$2,580.30.

**WHEREAS,** the award of contracts for services, supplies and maintenance of Borough facilities, equipment and personnel obligations enumerated in this resolution is necessary and in the public interest to provide for the efficient operation of the Borough; and

**DUNE & BEACH RENOURISHMENT COMMITTEE, COUNCILMAN STROHM**

**A. Report of the Dune & Beach Renourishment Committee**

**B. Action Items:**

Councilman Strohm moved the following resolution.

**RESOLUTION NO. 12/21/2009 – 15: PROVIDING FOR RESTORATION OF STORM DAMAGE TO THE DUNE SYSTEM**

**WHEREAS,** recent storms have caused severe erosion of the dune system along the entire length of the ocean beachfront; and

**WHEREAS,** the Dune Consultant, Robert Mainberger, P. E. (Hatch Mott MacDonald) has identified critical areas which should be accorded priority upon commencement of beach restoration efforts; and

**WHEREAS,** the Dune Inspector has determined that restoration is necessary along the entire ocean beachfront and without regard to the presently existing distance between the "new" scarp and existing improvements; and

**WHEREAS,** mechanical restoration (bulldozing) is predicated upon the availability of sufficient sand, as determined by the Dune Inspector; and

**WHEREAS**, it is recognized that the “critical” areas, as determined by the Dune Inspector, must be accorded priority in the restoration effort and shall be restored on an emergent basis whenever suitable sand is available; and

**WHEREAS** the oceanbeach dune system is the principal available defense against the assault of storm tides and waves and must be promptly and uniformly maintained; and

**WHEREAS**, it is the desire of the Mayor and Council to maintain the protective dune system for the benefit of all property within the Borough (public and private).

**IT IS NOW, THEREFORE**, this 21<sup>st</sup> day of December, 2009, RESOLVED by the Mayor and Council of the Borough of Mantoloking, Ocean County, New Jersey, as follows:

1. A state of emergency exists as relates to the storm damaged protective oceanbeach dune system;
2. The dunes shall be restored, by bulldozing, promptly upon the availability of suitable sand in the beach system;
3. No bulldozing or other mechanical restoration shall be commenced, at any location, without prior issuance of a permit from the Dune Consultant (Dune Inspector);
4. Restoration shall be performed in strict compliance with the terms, conditions and directions of the Dune Consultant (Dune Inspector). Violation of permit terms or conditions will result in revocation of the permit and/or the imposition of other available sanctions;
5. It is the intention of the Borough to provide bulldozing utilizing Borough employees, supplemented by such contractors as may, from time-to-time, be engaged by the Borough. Restoration by Borough forces or by contractors engaged by the Borough shall be at the sole expense of the Borough;
6. An oceanfront owner may, at his, her or its election and upon receipt of a permit, provide or perform restoration subject to and in accordance with the terms, conditions and specifications of the permit, including but not limited to commencement and duration. Such private efforts shall be at the sole risk and expense of the owner.
7. The Borough will deliver to each oceanfront owner an application for issuance of a dune restoration permit. The applicant shall either designate its proposed restoration contractor or shall identify the Borough as its restoration provider. All costs incurred, by any owner, in the event of selection of a private contractor shall be borne solely by the Owner(s); the Borough will provide restoration free of charge for the service.
8. The Borough of Mantoloking Code, Chapter XI – Protection of Beaches and Dunes, 11-1, Preservation and Protection of Dunes, provides:
  - (a) that the dune system (and maintenance thereof) benefits the entire Borough: “. . . interior lands as well as oceanfront premises. . .”
  - (b) that the Borough has the right to “cause their restoration in the event of damage or destruction. . .”;
  - (c) declares that (the Ordinance) is “. . . an exercise of the police power, in the interest of safety and welfare for the protection of persons and property. . .”;
  - (d) Sub-article 11.4, Enforcement and Protection, 11-4, provides for corrective action by an owner upon the direction of the Dune Inspector. Failure to comply with such directive shall enable the Borough to perform such act of protection and/or restoration at the ultimate cost of the property owner(s). Failure to comply with the directive of the Dune Consultant (Inspector) shall be a violation of the Ordinance.

The motion was seconded by Councilwoman Nelson and approved by unanimous voice vote.

**ORDINANCE NO. 578**

**AN ORDINANCE AMENDING CHAPTER XXX,  
SECTION 30-2.2 OF THE MUNICIPAL CODE OF THE BOROUGH OF  
MANTOLOKING, OCEAN COUNTY, NEW JERSEY, PROVIDING FOR  
DELETION OF “HALF-STORY”; AND  
AMENDING THE DEFINITION OF “ATTIC”**

**BE IT ORDAINED** by the Mayor and Council of the Borough of Mantoloking, as follows:

- I. (a) The definition of “half story”, Section 30-2.2 is deleted;
- (b) The definition of “attic”, Section 30-2.2 is amended.  
“Attic” – The level(s) proximately below the roof of a building and above the second story, which may be constructed or utilized for habitation.
- II. Appendix B, Bulk Standard:  
Delete the column “Half Story Habitation Area, To Second Floor Area Ratio”.
- III. Chapter XXX, Section 30-2.2 as hereby amended shall remain in full force and effect.
- IV. This Ordinance shall be effective upon final adoption.
