

**EMPLOYMENT AGREEMENT**

**THIS AGREEMENT** made the \_\_\_\_\_ day of March, 2019

**BETWEEN: BOROUGH OF MANTOLOKING**, a municipal corporation of the State of New Jersey, having its principal offices located at 202 Downer Avenue, Mantoloking, New Jersey, 08738, hereinafter referred to as “Borough” or “Employer”;

**AND: BART PETRILLO**, hereinafter referred to as “Zoning Official.”

**ARTICLE I  
DURATION OF AGREEMENT**

This Agreement shall be in full force and effect from the 8th day of April, 2019, through and including the 31<sup>st</sup> day of December, 2019.

**ARTICLE II  
MANAGEMENT RIGHTS**

The Employer hereby retains and reserves unto itself, without limitation, all powers, rights, authority, duties and responsibilities conferred upon it and vested in it by law and the Constitutions of the State of New Jersey and the United States, except as may be specifically modified by this Agreement.

**ARTICLE III  
SALARY AND TERMS OF EMPLOYMENT**

- A. The Zoning Official shall be compensated at the hourly rate of \$35.00 per hour and shall be guaranteed a minimum of ten hours per week.
- B. The Zoning Official will perform all the duties of Zoning Official and shall also assist in the training and mentoring of Deputy Zoning Official Colleen Malvasio.

**ARTICLE IV  
VACATIONS, HOLIDAYS, SICK LEAVE, ETC.**

- A. The Zoning Official acknowledges that he is not a full-time employee and will not be provided health benefits and prescription drug coverage by the Borough.
- B. The Zoning Official shall not be entitled to paid holidays, but is guaranteed payment for a minimum of ten hours per week, regardless of the occurrence of a holiday in any given week.

C. The Zoning Official shall be entitled to the same paid leave, bereavement leave, and education benefits as provided to other employees of the Borough in accordance with the Borough of Mantoloking Employee Manual.

**ARTICLE V  
SAVINGS CLAUSE**

If any section, clause, portion or article of this Agreement is subsequently deemed by a Court of competent jurisdiction to be illegal, such section, clause, portion or article may and shall continue in full force and effect absent the portion found to be illegal or unconstitutional.

**ARTICLE VI  
ZONING OFFICIAL'S RIGHTS AND PRIVILEGES**

Nothing contained herein shall be construed to deny or restrict Zoning Official's rights and privileges pursuant to any other applicable State laws or regulations. The rights granted to the Zoning Official hereunder shall be deemed in addition to those mandated by law.
