Mayor White advised that there was not a sufficient amount of time to discuss.

2. Police Boat

Mayor White advised that he met with Chief Ferris and Joe Celentano, Commodore of the Mantoloking Yacht Club.

Positives: Deterrent for speeding vessels and quick response time in the event of an emergency.

Negatives: Current boat will cost approximately \$14,000.00 to fix and requires two officers to operate.

Looking at the cost of a single person rib. The Yacht Club will do a fund raiser in early July.

Chief Ferris advised that the town would look at purchasing the boat and the Yacht Club will help with the cost of maintenance, operation and staffing. Current plan is to float the current boat 5 days a week. Have the boat functional for Memorial Day.

Councilman Nelson asked if any consideration was made for a joint Police and Fire Department Boat. Chief Ferris advised that it is a rescue tool for the borough.

Nancy Ness, 1057 Barnegat Lane, mentioned a fund that residents had for the boat in the past.

Councilman Gillingham- Residents paid \$100.00 each for the first boat. Municipal services should be the municipality’s obligation.

RESOLUTION SHARED SERVICE AGREEMENT “MOVE OVER” LAW ENFORCEMENT PROGRAM

WHEREAS, the Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq., authorizes the Borough of Mantoloking to enter into a contract for the provision of certain governmental services with the County of Ocean Police Services; and

WHEREAS, N.J.S.A. 40A:65-5 requires that such a contract be authorized by resolution; and

WHEREAS, the Borough of Mantoloking desires to participate in said Move Over Law Enforcement Program (hereinafter referred to as M.O.L.E.P. run by the Ocean County Prosecutors Office for the purpose of identifying, educating and removing reckless drivers from the roadway; and

WHEREAS, the M.O.L.E.P. receives funding from the State of New Jersey and County of Ocean; and

WHEREAS, the Municipality wishes to enter into an Agreement with the County for purpose of setting forth the terms and conditions regarding the assignment of police officers employed by the Municipality to the M.O.L.E.P.; and

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Borough of Mantoloking, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the execution of a Shared Services Agreement with the County of Ocean Police Services for Move Over Law Enforcement Program, said agreement is subject to the approval of the Borough Attorney.
2. That the Mayor is hereby authorized to execute and the Borough Clerk to attest to the Shared Services Agreement, and any other documents necessary to effectuate the terms of this resolution.
3. That a copy of the agreement referenced herein shall be kept on file and made available for public inspection at the Borough Clerk’s Office during normal business hours.
4. That a certified copy of this resolution, together with a copy of the agreement, shall be forwarded to the Office of the Prosecutor, Chief of Police and the Chief Financial Officer.

RESOLUTION NO. 2020-53
RESOLUTION: IN SUPPORT OF PARTICIPATION IN THE 2020 DISTRACTED DRIVER STATEWIDE CRACKDOWN APRIL 1- APRIL 21, 2020

WHEREAS, distracted driving is a dangerous epidemic on America's roadways. In 2017 alone, 3,116 people were killed in distracted driving crashes; and

WHEREAS, In New Jersey, driver inattention remains the most significant cause of fatal and incapacitating crashes. Driver inattention was listed as a contributing circumstance in 51 percent of the state’s crashes in 2017. Driver inattention was in fact listed as a contributing factor in crashes at a rate of eight than that of the next highest contributing factor (speed); and

WHEREAS, the State of New Jersey will participate in the Distracted Driving 2020 Statewide crackdown from April 1 – April 21, 2020 in an effort to raise awareness about the dangers of distracted driving, to offer deterrence through visible enforcement and issue summonses for relevant motor vehicle violations; and

WHEREAS, during the 2019 crackdown participating police agencies in the state issued 15,105 summonses for cell phone use/texting and 6,286 for careless driving; and

WHEREAS, the grant will pay for 100 hours of overtime enforcement during the crackdown period, with a maximum rate to be reimbursed of \$55.00 per hour.

IT IS NOW, THEREFORE, this 18th day of February, 2020, **RESOLVED** by the Mayor and Council of the Borough of Mantoloking, Ocean County, New Jersey, declares it's support for the Distracted Driving 2020 Statewide Crackdown from April 1 – April 21, 2020.

RESOLUTION NO. 2020-54

RESOLUTION OF THE BOROUGH OF MANTOLOKING, COUNTY OF OCEAN, STATE OF NEW JERSEY, APPOINTING RONALD S. GASIOROWSKI, ESQUIRE, OF THE FIRM OF GASIOROWSKI & HOLOBINKO, AS SPECIAL COUNSEL FOR THE BOROUGH OF MANTOLOKING

WHEREAS, the Borough Council previously appointed Ronald S. Gasiorowski, Esquire, of the firm of Gasiorowski & Holobinko, as Special Counsel for the Borough of Mantoloking for the representation of the Borough before the Brick Township Zoning Board of Adjustment to be compensated at the rate of Three Hundred Twenty-Five (\$325.00) Dollars per hour for services rendered to the Borough, for a total amount not to exceed \$17,500.00; and

WHEREAS, the Mr. Gasiorowski's efforts as Special Counsel for the Borough of Mantoloking for the representation of the Borough at the Brick Township Zoning Board of Adjustment have been extensive and required, to date, the provision of legal services in excess of \$17,500.00; and

WHEREAS, through the efforts of Mr. Gasiorowski and others, the applicant Vilamoura, Inc. has currently withdrawn its CAFRA application and sought an adjournment of hearing without a date certain for the Brick Township Board of Adjustment the Borough Council, but it is anticipated that the applications will be refiled and/or be continued; and

WHEREAS, the Borough Council therefore deems it desirable to authorize payment to Mr. Gasiorowski for work to date in the total amount of \$36,885.99 and to authorize extension of the agreement with Mr. Gasiorowski for such legal services as are necessary between the date of this Resolution and December 31, 2020.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Mantoloking, County of Ocean, State of New Jersey, as follows:

1. That payment of \$36,885.99 to Ronald S. Gasiorowski, Esquire, of the firm of Gasiorowski & Holobinko, for services previously provided is hereby authorized; and
2. That the Mayor is hereby authorized to execute and the Borough Clerk to attest to, respectively, the attached extension of agreement with Ronald S. Gasiorowski, Esquire of the firm of Gasiorowski & Holobinko in accordance with the provisions of this resolution for the provision of legal services of Special Counsel for the Borough of Mantoloking for the representation before the Borough at the Brick Township Zoning Board of Adjustment through December 31, 2020. The Special Counsel and his firm shall be compensated at the rate of Three Hundred Twenty-Five (\$325.00) Dollars per hour for services rendered to the Borough, for a total amount not to exceed \$17,500.00.
3. That this contract extension is awarded without competitive bidding as a "Professional Service" in accordance with N.J.S.A. 40A:11-5(1)(a)(i) of the Local Public Contracts law because it is for services to be performed by a person or persons authorized by law to practice a recognized profession.
4. That the Business Disclosure Entity Certification be placed on file with this resolution.
5. That a notice of this action shall be printed once in the official newspaper of the Borough of Mantoloking.
6. That a copy of the written determination of value by the Borough shall be placed on file with this resolution.
7. That this resolution shall become effective immediately.
8. That a certificate of availability of funds executed by the Chief Financial Officer is annexed hereto. The following are the line item appropriations or ordinances which

constitute the availability of funds for this contract: Legal Services- Special Counsel- 9-01-20-155-001-203-\$17,500.00 and Legal Expenses- Special Emergency 9-01-20-155-001-204- \$19,385.99
