VARIATION PROCEDURE

However, the barrier is not climable and conforms to the requirements of the International Residential Code 2018, section R-326, Barrier Requirements. You must pay the variation fee with a separate check in the amount of one hundred fifty dollars (\$150.00) made payable to the Borough of Mantoloking.

- 1. Fill out the APPLICATION FOR A VARIATION.
- 2. Part I to be filled out by your neighbor of the barrier you wish to share. Each neighbor sharing a fence requires a separate variation form.
- 3. Part II to be filled out by the person requesting the variation. Return this completed form notarized and submit it with your APPLICATION FOR A VARIATION form.
