MEC/Green Team Regular Business

Planning Board:

Patty Brand Memorial Garden Shoreline Protection & Garden Maintenance

• Barbara B. indicated that routine annual maintenance of the garden will start up in the spring, and that there are no other updates at this time. It was suggested that the Barnegat Bay Blitz on April 22nd should start at the garden.

Sustainable Jersey PSEG Grant

- Construction/Landscaping Advice for Residents Pamphlet.
 - Barbara Benz emailed a draft copy of the "Mantoloking Guide to Living in Harmony with Our Barrier Island Environment" at approximately 4:45 PM prior to the meeting. She noted that the brochure is being funded by the PSEG grant.
 - There was discussion regarding the contents and layout. Jan suggested that some information about composting be included in the pamphlet. The inclusion of rain barrels was also discussed.
 - Distribution logistics of the pamphlet was discussed, and Peter suggested that it be distributed with beach badges. However, because individuals purchasing beach badges aren't the intended audience, it was agreed that this would likely be a waste of brochures. Denise Boughton suggested however that it be distributed along with the Blue Books and Mantoloking Residential Guide.
- The final Report is due 5/21/23. The draft of this report will be available in April for comment by the MEC.
