The meeting was called to order at approximately 5:35 PM. A quorum was present.

## **Meeting Minutes**

Barbara Benz made a motion to accept the October 2021 Meeting minutes, and John Wesson seconded the motion. The minutes were approved.

#### **Chairman Comments**

Barbara Benz stated that she will be working on the MEC 2021 year-end report this month. She also asked for volunteers to do the minutes for the next couple of months. John Mooney and Jan volunteered for Dec. and Jan. respectively.

#### Green Team Business →

- Fall Sustainable Jersey PSE&G Grant Cycle: The Sustainable Jersey grant cycle which opens in November will accept applications, with a deadline date of February 11, 2022. There are four grants available. MEC expects to apply for the \$2,000 level grant. Also, the NJ Board of Public Utilities is offering grants, and this pertains to the state's energy reduction plan.
- Jan provided commentary regarding the constant idling of police cars parked In front of police headquarters. Dialogue concerning this matter is expected to continue. Barbara B. indicated that funding for municipal electric vehicles could possibly become available, and Jan stated that the mayor has concerns about the use of electric vehicles in our area as it is flood prone. Peter provided that when it comes time for replacement, ATV municipal vehicles which are used on the beach and around town, could be replaced with electric ATVs. There was also some discussion regarding the installation of charging stations in town with the increased proliferation of electric vehicles.
- Sustainable Jersey Spreadsheet: Jan suggested use of the spreadsheet from the Sustainable
  Jersey website to stay up to date with activities and subjects pertaining to updating our
  Sustainable Jersey Actions (animals in the community, electric vehicles, etc.) and working on
  new ones. Currently the goal is to maintain bronze status.
- Barbara B. indicated that she would register those members of the MEC/Green Team with Sustainable Jersey that are not already registered: John Mooney, John Wesson, and Peter Andruss. Once registered with the site, if they haven't already logged in, they will receive an

- invitation which they need to respond to in order to complete the registration.
- Additionally, the ERI (Environmental Resource Inventory), authored by Jan, should tie in with the Mantoloking Master Plan which is to be updated in 2027.

  - Happy Thanksgiving from the MEC
  - Contact our local Assembly people about a bill (A.4678) that exempts plastic material processed at advanced plastic processing facilities from State laws regulating solid waste disposal, thus allowing plastic incineration facilities off the hook from these laws that are geared toward protecting our environment.
  - Contact our local Assembly people about the "Recycled Content" bill (S.2515/A.4676) which
    if passed will create a strong market for recycled plastic and reduce the use of virgin plastic.
  - As of 11/4, Plastic straws only available upon request.
  - Reposting of meeting being held by BHEC to inform public about work on flooding.
