# RESOLUTION OF THE BOROUGH OF MANTOLOKING, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING AN EXECUTIVE **SESSION**

WHEREAS, the Open Public Meetings Act authorizes the Borough Council to enter into executive session to discuss certain matters pursuant to N.J.S.A 10:4-12; and

WHEREAS, the Borough Council desires to enter into executive session to discuss contractual matters related to Brick Township Municipal Utilities Authority (BTMUA) regarding four Curtis Point properties; and

# CAUCUS DISCUSSION ITEM: Robert Mainberger- Beach Replenishment

State Aid Agreement (SAA) discussed.

Costs presented as detailed and estimated in SAA and rounded:

- \$10,320,000 Total cost;
- \$5,160,000 Federal share at 50%;
- \$5,160,000 Local share (Borough and NJDEP)
- \$3,870,000 NJDEP/State share of 75% of local share;
- \$1,290,000 Borough share;
- \$645,000 Borough cost after split 50/50 with Ocean County.
- \$161,250 Annualized Borough cost over 4 year period of renourishment.
- Costs equate to Approx. 1.5% of Borough annual tax revenue, or less than \$300/yr. per property.
- after all cost sharing, Borough is paying 6.25 cents on the dollar for project, "No Brainer" due
  to value of healthy beach for storm protection and preserving property value of all Borough
  property owners.

Also discussed importance of Beach to Ocean County, and Mayor inserted into discussion that County governing body assured Borough that they would share in this project and all future project costs over the term of the program.

Council was advised that discussion held with USACE on day of meeting and anticipated project schedule was Approx. as follows: Advertise project in December of 2022;

- Project out to bid a minimum of 30 days
- Bids in hand by end of Jan. 2023
- Award anticipated in mid-February 2023
- Notice to Proceed to contractor anticipated for mid-March 2023.
- Project work period was 300 days, contractor decides where they start and how they place sand
- Initial project filled Mantoloking first due to critical nature of the Borough and exposed sea wall.
- Reliability of project cost estimate and funds being sufficient for award (Council was advised that USACE has structured bid to include a Base bid of work and numerous options to award additional sand placement if bids were favorable.
- USACE Program manager advised that their goal is to place as much sand as possible on the beaches and spend all Federally allocated funds.

Council was advised that Base bid for Mantoloking included Approx. 392,000 Cubic Yards of sand and that all options if taken would provide Approx. 611,000 cubic yards of sand in the Borough.

Discussion was conducted as to accuracy of estimates and it was indicated that estimates were made from survey conducted by the USACE in March of 2022, but we have a significant period of time and full winter season before sand placement which could affect numbers, but a pre-placement survey will be conducted to confirm exact volumes and that is why SAA is worded as estimated costs, not hard dollar amounts.

Borough was advised that project cost shares were to be allocated on a bases of the percent of sand actually placed in the Borough against the total volume of sand placed in the project.

Council was informed that plans were available in the mayor's office, and that at this time no sand placement was anticipated in the Borough project area north of Lyman as the beach conditions were excellent from Lyman to the Borough's common boundary line with Bay Head.

Council was advised that the project included dune grass replacement in limited areas and that the USACE was conducting Ph testing and would share results with the Borough to aid in future Borough fertilization programs for dune grass nourishment.

A general discussion was held regarding the potential for additional funds being available should bids be higher than expected, due to Covid escalated costs and significantly high present day fuel costs. It did not appear that it would be favorable to acquire additional Federal funds with a short time frame, but potentially the State could get discretionary funds from the Governor's office since the State is presently in good fiscal shape, but that condition may only be temporary.

Council was advised that the USACE did not think that the storms in Florida would adversely affect the project bidding as the storms did not place a demand on the larger ocean dredges anticipated for the project, the USACE had indicated that they had received various bids recently which were highly variable, but the most recent bid in Delaware was very competitive and it was also favorable that the larger companies all had a significant number of dredges presently employed in the northeast that could be available for the project.

It was also interjected at the end of the discussion that an additional meeting discussion would be needed to review the anticipated Ocean County agreement, as the County has indicted that they will advance their share to the Borough before the Borough is required to post their funds to the NJDEP anticipated in late February 2023.

RESOLUTION OF THE BOROUGH OF MANTOLOKING, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING THE RENEWAL OF MEMBERSHIP IN THE NEW JERSEY INTERGOVERNMENTAL INSURANCE FUND

WHEREAS, the Municipal Council of the Borough of Mantoloking (hereinafter the "Local Unit") has determined that MEMBERSHIP IN THE New Jersey Intergovernmental Insurance Fund (hereinafter the "Fund) established pursuant to Chapter 372, Laws of 1983 (N.J.S.A. 40A:10-36 et seq), is in the best interest of the municipality.

**NOW, THEREFORE, BE IT RESOLVED** by the Municipal Council of the Borough of Mantoloking in the County of Ocean in the State of New Jersey as follows:

**SECTION 1.** The Borough of Mantoloking hereby agrees to continue as a member in the "Fund" for a period commencing on 1/1/2023 and terminating on 12/31/2025 for the following types of insurance coverage:

a) Workers Compensation and Employers Liability
 b) General Liability (including Police Professional & Public Officials Liability);
 c) Motor Vehicle and Equipment Liability Coverage;
 d) Property Damage (including Building & Contents, Automobile Physical Damage, Contractors Equipment and Boiler & Machinery)
 e) Environmental Impairment Liability
 f) Cyber Liability

**SECTION 2.** Local Unit agrees to enter into and abide by the terms of the Indemnity and Trust Agreement, attached hereto as Exhibit 1. Local Unit hereby authorizes and directs Borough of Mantoloking to execute the Indemnity and Trust Agreement and such other documents as are necessary to comply with the requirements if the Fund.

**SECTION 3.** The Bylaws of the New Jersey Intergovernmental Insurance Fund are hereby adopted and accepted by the Local Unit and the Local Unit hereby agrees to conduct its membership in the "Fund" according to the rights and obligations set forth therein.

<u>SECTION 4...</u> The Local Unit certifies that it has never defaulted on claims under a self- insurance plan and that it has not had its insurance canceled for non-payment of premium for a period of at least two (2) years prior to this application.

<u>SECTION 5.</u> <u>Inconsistent Resolutions.</u> All resolutions, or parts thereof that are or may be, inconsistent with provisions of this Resolution are hereby repealed to the extent of such inconsistency.

**SECTION 6.** Severability. If any section, paragraph, subdivision, clause or provision of this Resolution shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Resolution shall be deemed valid and effective.

**SECTION 7.** Effective Date. This Resolution shall take effect upon its passage.

# INDEMNITY AND TRUST AGREEMENT

**AGREEMENT** made this between the New Jersey Intergovernmental Insurance Fund, hereinafter referred to as the "Fund", with an address c/o Polaris Galaxy Insurance, LLC., 777 Terrace Avenue, Hasbrouck Heights, New Jersey 07604 and the Borough of Mantoloking hereinafter referred to as "Local Unit", located at 202 Downer Avenue, Mantoloking, New Jersey 08738

WHEREAS, the Mayor and Council of the Borough of Mantoloking has adopted a Resolution dated 11/14/2022, agreeing to continue its participation in the "Fund" and approving of the Bylaws, as approved by the Commissioner of the Department of Banking and Insurance and the Department of Community Affairs of the State of New Jersey.

**WHEREAS**, N.J.S.A.. 40A:10-36 et seq, and the regulations implemented thereunder in N.J.A.C. 1:15-2.1 et seq, require a written agreement between the individual local units and the "Fund".

**NOW, THEREFORE**, in consideration of the mutual promises and covenants of the parties, they agree as follows:

- 1. "Local Unit" agrees to participate as a member of the "Fund: and contribute such sums and pay such assessments into the "Fund" that are required for the administrative costs and claims for the following types of coverage:
- a) Workers Compensation and Employers Liability Monoline
- b) General Liability (including Police Professional & Public Officials Liability);
- c) Motor Vehicle and Equipment Liability Coverage;
- d) Property Damage (including Building & Contents, Automobile Physical Damage, Contractors Equipment and Boiler & Machinery)
- e) Environmental Impairment Liability
- f) Cyber Liability

- 2. "Local Unit" affirms that it has not been in default on any insurance premium due any insurance carrier in the preceding two (2) years, or on any claim due under any self-insurance.
- 3. "Local Unit" hereby accepts the Bylaws of the "Fund" as approved by the Commissioner of the Department of Banking and Insurance and the Department of Community affairs of the State of New Jersey and agrees to be bound by same.
- 4. "Local Unit" agrees to continue participation in the "Fund" to the extent designated in Paragraph above for a period from 1/1/2023 until and including 12/31/2025

- 5. "Fund" agrees to operate the insurance pool established by the parties and administer all monies contributed to the "Fund" in compliance with the provisions of the Local Fiscal Affairs Law (N.J.S.A. 40A:5-1 et seq), the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq), the enabling legislation authorizing the "Fund", (N.J.S.A. 40A:10-36 et seq), the Bylaws of the
- "Fund", and such other rules and regulations as govern the custody, investment and expenditures of public funds by local units. In furtherance thereof, "Fund" agrees to employ an individual duly certified as a Municipal Finance Officer to administer the funds of the "Fund".
- 7. "Local Unit" agrees to be jointly and severally liable for the assumption and discharge of the liabilities of each and every other member of the "Fund", but only to the extent of its participation in the type of coverage specifically designated in Paragraph 1 above.
- 8. To further the intent and purposes of Paragraph 5 above, "Fund" agrees that all assessment payments made by "Local Unit" shall be held in trust for the benefit of "Local Unit". Separate trust accounts must be established by the "Fund" pursuant to N.J.S.A. 11:15-2.13. The monies from said fund shall be disbursed solely for the payment of claims, allocated claim expenses and excess insurance or reinsurance premiums for the risk or liability coverage which "Local Unit" has agreed to participate in pursuant to paragraph 1 above. The funds on deposit in one trust account for a specific type of coverage may not be expended, assessed or attached for use by the "Fund" for that "Local Unit" or any other "Local Unit's" obligations or liabilities for any other type of coverage it may be participating in the "Fund".
- 9. "Local Unit" acknowledges that upon payment of its assessment into the trust account, it shall not have any further right to said funds except as deemed surplus and returnable by the "Fund" in accordance with the "Fund's" Bylaws and regulations or in the event of termination of the "Fund" and then only to the extent authorized by its Bylaws and regulations of the State of New Jersey.
- 10. "Local Unit" agrees that no later than ninety (90) days prior to the expiration of the term, they shall advise the Fund Administrator in writing of its intent to either renew or terminate its membership, the "Fund", at its sole option, shall be entitled to assume that any member delinquent in its notice requirements under this section, shall have renewal membership.
- 11. "Local Unit" agrees that if it fails to promptly pay any such assessment charged to it or to comply with the Bylaws and regulations of the "Fund", that it shall indemnify the "Fund", its officers, commissioners and Agencies for any loss or damage resulting from such failure.
- 12. This agreement shall be governed by the Laws of the State of New Jersey.
