6. <u>PRIVILEGE OF THE FLOOR:</u> Mayor George C. Nebel opened the meeting for public comment and questions about the agenda.

Questions and comments from the public on the Beach and lifeguards:

- Joann Lygas, 970 Barnegat Lane, asked about the requirements needed if lifeguards are hired.
- Attorney Jean Cipriani DEP and Board of Health requires bathrooms at access points
- Robert Mainberger dealing with Board of Health application process What is difference of cost of contract with Scout Lifeguards versus borough employing lifeguards Councilman White said hiring Scout as a Corporation was not feasible, next option to hire lifeguards who will fill out applications.
- Councilman Gillingham responded it is a wash

Ms. Lygas also inquired if there are any apparent conflicts of interest with those members of Council that are part of the Mantoloking Beach Association and if they should recuse themselves from voting Councilman Rzemieniewski responded "no"

Peter Flihan, 1105 Barnegat Lane, wanted to know if the \$75 beach badge is for all beaches or just those with lifeguards.

Dan Hurley, 1106 Barnegat Lane, had concerns regarding the \$75 badge fee with no services. Suggestion made regarding an Emergency Phone with only 911 access be installed in secure manner at all beach access points. He also suggested that thought be given to roving ATV's equipped with life guard equipment and lifeguards until a more permanent solution is achieved.

Councilman Amarante explained South Beach charges \$525 for family membership with an unlimited number of badges.

Environmental Commission meetings are held the 2nd Tuesday of the month at 4:30 p.m. The public is welcome to attend the meetings at the Sailing Center.

- <u>MUNICIPAL RELATIONS COMMITTEE</u> Councilman Amarante stated no report of the Mantoloking Relations Committee.
- 11. <u>MUNICIPAL SERVICES COMMITTEE</u>, Council President White presented the monthly reports from the Public Works Superintendent, Construction Official, Land Use Officer and Building Committee and moved the following resolutions A & B: The motion was seconded by Councilman Amarante and approved by unanimous voice vote.

Councilman White asked Public Works Manager, Scott Hulse, to speak to the public. He stated that all 14 access points are open. Dune Fencing is available to Ocean Front Homeowners, call Lynne Hazelet at the Borough Hall to reserve fencing. The Public Work's Department started to push sand at the northern end of town. They will do one more push.

Liz Huston, 1339 Ocean Avenue, had questions regarding additional fencing by access points. Robert Mainberger, Mott McDonald, advised that additional fencing is optional, not mandatory. If you want to put up fence on dune and delineate property boundary you can do that. The planted grass is coming in great. The Army Corp placed fencing at the tow of dune, you can open it, and if it obstructs your view you can remove it. Mr. Mainberger also explained if fence is installed on either side of split rail fence at walkways there could be an issue if a dune starts to form and may prevent you from removing it.

Valerie McDowell, 1122 Barnegat Lane, car pulled into a lot at the end of Herbert Street and got stuck in the sand. She asked if property owners can place a fence around the property so people don't drive on it. Councilman White advised that we can ask them.

- Councilman Nelson wanted to hear from the experts in the room regarding their perspective. Borough Attorney, Jean Cipriani, responded that she is legally comfortable with the Borough operating guarded beaches. All lifeguards need to have required licenses. She developed a lifeguard application.
- Councilman White stated we will hire Wade to be Head Lifeguard and he will be working with Chief Ferris and Lieutenant Barcus and be a part of the Police Department.
- Councilman Nelson-fiscal perspective in terms of the right budget being in place. April Yezzi,CFO- looking at all expenditures, this is the first year doing this, captured all the costs. An estimate of \$75 a badge fee. There are a lot of variables.
- Councilman Nelson-public safety-lifeguard supervision is not in the police contract. Chief Ferris – said she met with Wade twice and this will be a lot of work. Wade will start working next Monday. Lifeguards will be vetted and meet standards. We think we have captured all the costs. We will make it work the best we can.

Councilman Nelson indicated he is personally torn with his vote. He asked is we can amend the ordinance and put an expiration date. Attorney Cipriani advised that she sent a version with the sunset and that the Borough is committing to the summer of 2018. Language is already there.

Councilman White indicated that we will have to redo the ordinance for next summer.

Councilman Amarante inquired if there is a detailed plan to avoid overtime for head lifeguards. Chief Ferris -we just don't know, 3 lifeguards for each stand in town for 40 hours a week and will find somebody as assistant head lifeguard. We will be micromanaging the payroll.

Councilman Amarante – this is a fluid situation. Going back to the budget, don't know items of additional expense.

Borough Attorney, Jean Cipriani, reached out to the adjuster, made him aware of no third party.

- 1. on going conversation with the NJ Jiff
- 2. told the adjuster I would let him know if there will be lifeguards or not.

Councilman Nelson – consider putting Chief Ferris to explore looking at other municipalities, this is not a popularity contest. Call on the Mayor and Council President to form committee and nip this in the bud for next week. No council members on it. People in the public. Councilman Rzmieniewski, the Mayor appointed a committee

Councilman Nelson - it was not ideal, we need to get it right for next year.

Councilman White – committee is vital and he likes small committees, every part of town will be represented. Badge checkers will have a clicker. Meetings with residents and move forward together to have a good result next summer.

D. RESOLUTION NO. 05/15/2018-08: RESOLUTION OF THE BOROUGH OF MANTOLOKING, COUNTY OF OCEAN, STATE OF NEW JERSEY, APPOINTING WADE BREDIN ON A SEASONAL BASIS AS HEAD LIFEGUARD FOR THE 2018 BATHING SEASON

WHEREAS, the Borough of Mantoloking is in need of the services of a head Lifeguard for the 2018 bathing season, and

WHEREAS, Wade Bredin has the necessary certification to serve as a lifeguard and the experience in lifeguard training, supervision and scheduling to serve as Head Lifeguard.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Borough of Mantoloking, County of Ocean, State of New Jersey as follows:

- 1. That Wade Bredin be appointed as Head Lifeguard for the 2018 bathing season at a salary of \$17.50 per hour, effective May 16, 2018.
- 2. That a copy of this resolution shall be forwarded by the Borough Clerk to the Chief Financial Officer the Chief of Police and Wade Bredin.

 <u>DUNE & BEACH COMMITTEE</u>: Councilman Nelson presented the reports of the Dune & Beach Committee and Ocean County Block Grant Program and moved the following resolutions.

Councilman Amarante agreed with Councilman Nelson and thanked Council President White and the staff. He stated for the record the following:

I would like to go on record with my thoughts regarding the Town of Mantoloking providing lifeguards:

First, to those who say that the town is obligated to provide lifeguards this summer, I respectfully disagree. The fact that a private entity that served SOME of our residents has decided not to operate does not, in my opinion, automatically place that requirement on the town. It was prudent that the town agreed to investigate the possibility of taking over.

Some residents are asking, "Why are we still talking about this?" My response to that is that this is not an easy decision when you look at all the possible ramifications for our town both now and in the future if we do provide lifeguards. I believe most residents, including myself, would prefer to have lifeguards in some manner for this summer and beyond. The question is who should provide them, at what level, at what cost to taxpayers and, as I stated previously, with what possible ramifications both now and in years to come.

I have suggested that the town provide lifeguards at Downer Ave only for 2018 as a one summer emergency solution with an expiration date on an ordinance authorizing such. This proposal, along with the continued operation of South Beach Association would provide the town with almost equivalent coverage to what was available last summer. I also would request that the mayor and council president commit to the formation of a geographically representative committee to investigate all options for 2019. The suggestions offered in Councilman Nelson's comments last week would be a good starting point for discussion. I would respectfully request to be a part of this committee.

Finally, I believe part of my responsibility as a councilperson is to carefully examine any and all substantial expenditures being proposed with the goal of always protecting the town and minimizing the tax burden on residents. I take this responsibility very seriously and my opinion and vote on an issue will not be influenced by comments that Mantoloking is a wealthy town.

I would be happy to discuss my thoughts further with any resident.

Councilman Nelson discussed amending Ordinance 678 to only include Downer Avenue. Borough Attorney, Jean Cipriani, advised that you can set that level driven by amount of lifeguards.

Councilman Amarante needed clarification regarding who is the authority that dictates how many beached the borough operates. Borough Attorney, Jean Cipriani, advised that the Governing Body does and the Ordinance does not.

Councilman Gillingham explained when the budget is reviewed and personnel is hired. A Tentative budget provides for six lifeguards, council has the obligation to determine that.

Chief Ferris – to schedule two beaches, we will need 6 hires, however, we might need 12 to 20 people to cover staffing needs.

ORDINANCE 678

AN ORDINANCE OF THE BOROUGH OF MANTOLOKING, COUNTY OF OCEAN, STATE OF NEW JERSEY AMENDING THE BOROUGH CODE OF THE BOROUGH OF MANTOLOKING, SO AS TO AMEND CHAPTER 10, ENTITLED "BEACH REGULATIONS"

BE IT ORDAINED by the Mayor and Borough Council of the Borough of

Mantoloking, County of Ocean, and State of New Jersey, as follows:

SECTION 1. Chapter 10 of the Borough Code of the Borough of Mantoloking, entitled, "<u>Beach Regulations</u>" is hereby amended and supplemented so as to read in its entirety as follows:

10-1 TITLE AND PURPOSE.

10-1.1 Short Title.

This chapter may be cited and referred to as "The Beach Ordinance of the Borough of Mantoloking.

10-1.2 Findings, Declaration and Purpose.

This chapter is declared to be an exercise of the Police power in the interest of safety and welfare for the protection of persons and of property.

Access to the Atlantic Ocean beaches within and abutting the Borough of Mantoloking has, with increased population and improved transportation, become a matter of public concern. The character and quality of the access and use of the beach under the Public Trust Doctrine, as applied in New Jersey and proclaimed in various decisions of our Courts, necessitates that each community bordering on the Atlantic Ocean continuously review its policies, facilities, and procedures, together with an evaluation of the use and demand for use of beaches within the community by members of the public. The Borough is a small, fully developed, single-family, tranquil, noncommercial resort and year-round residential community on a very narrow portion of the barrier beach. Except for certain public access routes, the oceanfront at Mantoloking is privately owned, dedicated and restricted to residential use, up to the mean highwater line. These private property rights are, of course, subject to the rights of the public under the Public Trust Doctrine.

The Borough of Mantoloking recognizes its obligation to provide public access to the ocean under the Public Trust Doctrine. In furtherance of this obligation, the Borough will provide lifeguarding services at a limited number of locations for the summer of 2018, Persons utilizing the beach for bathing or swimming at unguarded areas or when lifeguards are not present do so at their own risk. Persons using the beach for surfing, kayaking or any other recreational use are strongly cautioned that they perform such activities at their own risk.

In order to evaluate and implement such participation by the Borough as is deemed appropriate, the Borough has acquired and will continue to acquire relevant data concerning the use of the beaches by requiring those who use the ocean beaches to apply for a seasonal beach badge. Beaches within the Borough are receiving increased use by members of the public who do not reside in the Borough and who may, therefore, not be familiar with local conditions and beach regulations. Further, the increased utilization of the beach by surfers and kayakers necessitates specific regulation of these activities. Surfing presents inherent risks to its participants and to others; surfers and bathers cannot safely co-exist in close proximity to each other. It is, therefore, deemed necessary to control and regulate surfing so that, to the extent reasonably possible, the interests of all persons using the ocean may be reasonably accommodated.

The Borough of Mantoloking does, by the adoption of this chapter, express its continuing intention to establish and maintain a viable and balanced response to judicial determinations concerning rights, both public and private, to the utilization and enjoyment of the ocean and bay beaches. The procedures, rules and regulations, as set forth and authorized herein, are deemed necessary and appropriate to provide for the health, safety and welfare of all concerned.

This chapter is not intended to be administered, enforced or interpreted in any manner that will expand public rights upon private property within the Borough, but rather to provide for access by the public pursuant to the Public Trust Doctrine and to exercise the Borough's general Police power over areas within its jurisdiction.

10-2 DEFINITIONS.

All terms and language utilized in this chapter shall be accorded their common and customary meaning, except where specifically defined herein as follows:

Access Ways shall mean any public route, way or path providing ingress and egress to the Public Trust Lands to seaward of the Mean High-Water Line.

Bathe shall mean to enter a body of water and to become immersed therein.

Beach shall mean that area between the Mean High-Water Line and the Seaward Edge of the Dune or upland vegetation along the bay front.

Beach Area shall mean that area between the Mean High-Water Line of the Atlantic Ocean, in reference to the North American Vertical Datum of 1988 (NAVD 88) as established by the U.S. Army Corps of Engineers (USACE) and the seaward edge of the dune.

Beach Badges shall mean any badges issued by the Borough or by a private **beach** association operating upon beaches within the Borough which provide lifeguard services. **Beaches** shall mean the areas defined above ("**beach**" and "**beach** area") and any Bay beaches.

Boat shall mean a watercraft or vessel of any size, and propelled by paddles, oars, sails or an engine.

Cooler shall mean a device, container or apparatus which is utilized to keep things cool. **Household** shall mean all occupants of a residential unit.

Litter shall mean garbage, rubbish, and all other waste material which, if thrown or deposited as herein prohibited, tends to create a danger to public health, safety and welfare, or which will degrade the aesthetics of the **beach**.

Mean High-Water Line shall mean the line formed by the intersection of the tidal plane of mean high tide with the shore (mean high tide being a mean of all high tides over a period of 18.6 years).

Oceanfront shall mean abutting the Atlantic Ocean.

Ocean shall mean the Atlantic Ocean.

Person shall mean any individual, firm, partnership, corporation or association of persons.

Public Trust Doctrine shall mean the common law doctrine establishing the public's right to access and use navigable waters and tidally flowed lands seaward of the mean high water line which is held in trust by the State for the use by all citizens.

Public Trust Doctrine Area shall be the area seaward of the mean high water line.

Riparian Lands shall mean lands traversed or covered by flowing navigable waters.

Surf shall mean being in the water accompanied by a surfboard or other rigid device capable of being ridden erect on a breaking wave. The utilization of a kayak or similar vessel to repeatedly traverse or cross through the surf line, as opposed to the mere launching and landing of same for purposes other than riding waves, shall also be deemed surfing.

Surfboard shall mean a long narrow board utilized for surfing equipped with a tethering device to fasten the board to the rider.

10-3 BEACH BADGES.

10-3.1 When Required.

Beach badges are required for persons **over** twelve (12) years of age, from June 15th to Labor Day of each year, inclusive, between the hours of 10:00 a.m. and 5:00 p.m.

10-3.2 Application and Fee.

Badges may be <u>purchased</u> at the municipal facilities on Downer Avenue, or such other location(s) as may be advertised, **from 10:00 a.m. and 5:00 p.m.** <u>The cost will be</u> **\$75.00** dollars per badge for a seasonal badge. The beach badge shall be valid for the entire summer season of the year it is issued. <u>Daily badges will be sold for</u> **\$10.00** dollars per badge. No replacement badges will be issued without payment of the entire, then current, badge fee.

10-3.3 Display of Badge; Nontransferability.

Mantoloking beach badges are not transferable **except within households** and must be prominently displayed at all times while upon the access routes, beach or adjacent waters during such hours as access to public trust doctrine areas is managed by the Borough and/or its agents.

10-3.4 Badges Issued by Private Beach Associations.

Persons wearing badges issued by private beach associations shall be accorded the same rights and shall be subject to the same regulations as registrants wearing municipal beach

badges.

10-3.5 Surfers, kayakers and fisherman.

Surfers, kayakers, paddleboarders and fisherman using only the beach area or waters covered under the public trust doctrine at Mantoloking are not required to obtain Borough beach badges **during such time as they are actively engaging in surfing, kayaking, paddleboarding and fishing**. Surfers shall not pay any additional fee for a surfing permit or badge. Surfers are not required to display permits or decals on surfboards.

10-3.6 Promotional badges.

The Borough Council may authorize by resolution promotions consisting of a certain free daily or seasonal beach badges to be distributed by the Mayor or Chief of Police to enhance tourism.

10-4 RULES AND REGULATIONS GOVERNING BEACH ACTIVITIES.

10-4.1 Public Recreational Bathing Beaches

The Borough or Mantoloking <u>will operate one or more Public Recreational Bathing</u> <u>Beaches pursuant to N.J.A.C. 8:26</u> Persons utilizing the beach for bathing or swimming at unguarded areas or when lifeguards are not present do so at their own risk. Persons using the beach for surfing, kayaking or any other recreational use are strongly cautioned that they perform such activities at their own risk.

10-4.2 Trespass on Private Property.

Persons shall not trespass on private beach property not subject to the public trust doctrine or lands covered under Perpetual Easement Agreement with the Borough and the NJDEP.

10-4.3 Beach Badges.

- a. *Display of Badge*. All persons upon the beach and access ways or in or upon adjacent waters, as the case may be, shall wear and prominently display an approved current badge which has been registered in the name of that person, or in the name of that person's household.
- b. *Enforcement.* All persons upon the **beach** and access ways or in or upon adjacent water during the hours of **10:00 a.m. to 5 p.m**. from June 15th through Labor Day shall, if not in immediate possession of an appropriate beach badge, promptly leave the beach upon the request of authorized enforcement personnel

10-4.4 Littering.

No person upon the beach and access ways or in or upon adjacent waters shall throw or deposit litter except in public receptacles and in such a manner that the litter will be prevented from being carried or deposited by the elements. Where public receptacles are not provided, all such litter shall be carried away by the person responsible for its presence and properly disposed of elsewhere. No person shall throw or deposit litter into the bay or ocean or lands adjacent to same.

10-4.5 Food and Beverages on the Beach.

No person upon the beach and access ways or in or upon adjacent waters shall picnic on the beach or otherwise possess, carry or consume food or beverages on the beach. The possession or consumption of water or any other nonalcoholic beverage in a nondisposable, durable-reusable container is, however, permitted.

10-4.6 Fires.

No person upon the beach and access ways shall ignite, maintain or allow open fires.

10-4.7 Noise

No person upon the **beach** and access ways shall play sound reproduction devices of any nature, which are operated so as to be audible beyond a range of six (6) feet from the device.

10-4.8 Nudity and Disrobing.

No person upon the beach and access ways or in or upon adjacent waters shall:

- a. *Appear in State of Nudity.* A person shall be found in a state of nudity when his clothing or absence of clothing exposes to public view a person's anus, genitals, pubic area or female areolae.
- b. change clothes, dress, undress or otherwise to disrobe, except outer wraps.

10-4.9 Games

No person upon the beach and access ways or in or upon adjacent waters shall play paddleball, beach tennis, skim board or throw, bat or catch a baseball, football, tennis, basketball, softball, rubber ball, beach ball, Frisbee or any other object or to fly kites or any other object so close to nonparticipants as to constitute a hazard to them or to disturb the general tranquility of other persons upon the beach.

10-4.10 Animals.

a. Unless otherwise permitted by this chapter, no person who owns, keeps or harbors any dog or other animal shall suffer or permit such animal upon any premises, public or private, other than those owned or occupied by such person or upon which private premises the owner shall have a right of presence, unless, leashed, and under the direct and immediate control of a responsible person.

b. No dogs or other animals shall be permitted upon Borough-owned beaches or upon beaches under Borough jurisdiction, i.e. lands below the mean highwater line; except however:

1. Leashed dogs and other animals when accompanied by a responsible person shall be permitted on beaches between May 15th and October 1st, only between sunrise and 10:00 a.m. and from 5:00 p.m. to sunset, however no dog or other animal shall be suffered or permitted to be in or upon the area known as North Lagoon (adjacent to Bergen Avenue) between May 15th and October 1st. This ban and prohibition shall and does extend to and include the entire area from the northerly edge of the street pavement to the water's edge and on the east and west by the lines formed by the extension of the bulkheads, southerly, to the points of intersection with the northern

edge of pavement.

2. From October 2nd to May 14th dogs and other animals shall be permitted upon beaches and access ways unleashed, but only when under the direct and immediate control of a responsible person.

3. An owner, tenant or occupant of oceanfront property shall not be deemed in violation of the chapter, at any time, while in the act of permitting his or her dog or other animal to transit from the lot to or from the ocean abutting the upland lot. Owners, tenants or occupants of private property (beaches) shall not be required to leash their animals while on said property.

4. Dogs and other animals may be permitted to swim unleashed when under the direct and immediate control of a responsible person.

c. Notwithstanding the foregoing, no person owning, harboring, keeping or in charge of any dog or other animal upon any oceanfront lot owned or occupied by such person shall fail to remove from the beach and to dispose of in a sanitary manner, any feces deposited by any such animal.

d. Any person in charge of and accompanying a dog or other animal in the Borough except on private property owned or occupied by the owner of the animal shall have, in his or her immediate possession, a container suitable for removal of any feces which may be deposited by the animal.

10-4.11 Fishing.

No person upon the beach and access ways or in or upon adjacent waters shall fish within two hundred (200) feet of any swimmer or person in the water.

10-4.12 Boats.

No person upon the beach and access ways or in or upon adjacent waters shall launch, operate or retrieve any boat within two hundred (200) feet of any swimmer or person in the water.

10-4.13 Vehicles.

No person upon the **beach** and access ways or in or upon adjacent waters shall operate vehicles of any nature whatsoever with the exception of **Borough-owned or sponsored** vehicles and life-saving emergency vehicles operated by beach associations.

10-4.14 Swimming Under the Influence.

No person upon the **beach** and access ways or in or upon adjacent waters shall swim, enter or remain in the water while under the influence of any substance which will increase the natural hazard of such activity.

10-4.15 Dangerous Conditions.

No person upon the **beach** and access ways or in or upon adjacent waters shall enter the water, swim or attempt to swim or surf under conditions which are beyond the apparent capacity of the person and which may endanger others.

10-4.18 Response to Borough Personnel.

No person upon the beach and access ways or in or upon adjacent waters shall fail to

respond to directions of Borough personnel or agents consistent with the enforcement of this chapter.

10-4.19 Restrictions on the use of umbrellas and other fixtures on the beach.

- A. Umbrellas with a collapsible circular shade no greater than eight feet in diameter stretched over hinged ribs radiating from a center pole no greater than 7 feet 6 inches in height, and without grounding lines, ropes, or sides are permitted on the beach.
- B. Devices designed or used to shade infants and small children, also known as "baby tents," no larger than 36 inches high by 36 inches wide by 36 inches deep, are permitted on the beach.
- C. Umbrellas and baby tents shall be secured such that uncontrolled movement of the device is restricted. Baby tents and canopies when secured with fasteners, stakes, weights, or the like shall not endanger beach patrons. Anchoring lines, tethers, or the like shall not extend beyond the perimeter of the baby tent or canopy.
- D. Umbrellas and baby tents shall be removed from the beach daily.
- F. Excluding umbrellas and, baby tents described above in this section, other shading devices including, without limitation, tents, tarps, canopies, cabanas, pavilions, temporary restroom facilities, and similar devices, or any materials mounted on supports are prohibited except in connection with an approved special event or ceremony.

10-4.20 Other prohibited acts

- A. No person shall sleep upon the beach between the hours of 5p.m. and 10 a.m.
- B. Smoking is not permitted on the beach or access ways.

10-5 SURFING RULES AND REGULATIONS.

10-5.1 Date and Time Limitations.

Surfing regulations shall be enforced during the same dates and times that the Borough enforces beach regulations regarding bathers and swimmers, i.e., from June 15th to Labor Day of each year, inclusive, between the hours of 10:00 a.m. and 5:00 p.m.

10-5.2 Assumption of Risk.

Surfing will be permitted at all times year round without regard to date or time of day, or to conditions of wind, waves, or weather. Surfing shall, at all times, be at the sole risk of the surfer.

10-5.3 Distance from Swimmers and Bathers.

Surfing within two hundred (200) feet of a bather or swimmer is prohibited. In the event of conflict or doubt, as to the separation distance or as to priority, surfers shall give way to bathers or swimmers in recognition of the inherent potential for injury in the event of contact or close proximity.

10-5.4 Display of Badge.

Surfers shall at all times, possess and display, upon request, a current Borough beach badge or a current badge issued by the Mantoloking Beach Association or South Beach Association if they are not actively engaging in surfing.

10-5.5 Tether Devices.

Surfers shall at all times, utilize a tether device while surfing.

10-5.6 Compliance with Regulations.

Surfers shall at all times comply with all other provisions of this chapter, as amended, and all other regulations not inconsistent with this chapter.

10-6 ADMINISTRATION AND ENFORCEMENT.

10-6.1 Enforcement by Borough Police.

This chapter and the rules and regulations set forth herein or as may hereafter be adopted by resolution of the Borough Council shall be enforced by the Chief of Police utilizing law enforcement officers and/or such other Borough personnel as may be made available for this purpose. The complaint of any person who may allege a violation of this chapter shall be accepted and prosecuted in the same manner, as though initiated by the within described enforcement personnel.

10-7 PENALTIES.

10-7.1 Violations and Penalties.

Fines shall be assessed for violations consistent with Borough Ordinance Chapter 7:12-4. Upon conviction of a first violation of any provision of this chapter, the violator shall be subject to a fine of not more than one hundred (\$100.00) dollars but not less than twenty-five (\$25.00) dollars or detention for not more than five (5) days, at the discretion of the Court. Upon conviction of a second and/or subsequent violation of this chapter the violator shall be subject to a fine of not more than five hundred (\$500.00) dollars but not less than fifty (\$50.00) dollars or detention for any more than ninety (90) days, at the discretion of the Court.

10-7.2 First Offense.

For a first alleged violation of any provision of this chapter and, unless the summons and complaint shall specifically mandate "court appearance required", a defendant may enter a guilty plea by mail or upon appearance in the office of the Court Administrator of the Municipal Court. Upon entry of the guilty plea and payment of a fine in the sum of twenty-

five (\$25.00) dollars, the matter shall be concluded without the necessity of a court appearance by the defendant.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are

hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of

this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.

ORDINANCE 18- 679

AN ORDINANCE OF THE BOROUGH OF MANTOLOKING, COUNTY OF OCEAN, STATE OF NEW JERSEY AMENDING THE BOROUGH CODE OF THE BOROUGH OF MANTOLOKING, SO AS TO AMEND CHAPTER 2, ENTITLED "ADMINISTRATION"

BE IT ORDAINED by the Mayor and Borough Council of the Borough of

Mantoloking, County of Ocean, and State of New Jersey, as follows:

SECTION 1. Section 2-16 of the Borough Code of the Borough of Mantoloking, is hereby amended and supplemented so that it shall be entitled, "Beach Patrol," and so that it shall read in its entirety as follows:

§ 2-16 Beach Patrol.

A. The Borough shall employ a Beach Patrol consisting of a Head Lifeguard and lifeguards and other seasonal employees as may be required for the proper supervision of public bathing at designated public beaches within the Borough of Mantoloking.
B. The Chief of Police shall determine the required qualifications of the lifeguards, badge, checkers, and other personnel, and shall set forth the scope and nature of their duties and hours of employment, except that all lifeguards shall be required to be lifeguard, CPR, and first aid certified.

C. Lifeguards shall have charge, control, and supervision of the bathing, swimming, and surfing at the respective beaches for the individual designated sports and generally on all the beaches and beachfront of the Borough and in the waters adjoining the same.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are

hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of

this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
