5. RESOLUTION NO. 07/18/2017-01: MINUTES OF PREVIOUS MEETINGS

RESOLVED, the Mantoloking Borough Council approved the following minutes as printed and distributed.

Councilman Gillingham moved to approve the minutes as distributed. The motion was seconded by Councilman White and approved by unanimous voice vote.

PRIVILEGE OF THE FLOOR: Mayor George C. Nebel opened the meeting for public comment and questions about the agenda.

7. MUNICIPAL SERVICES COMMITTEE, Council President White presented the monthly reports from the Public Works Superintendent, Construction Official, Land Use Officer and Building Committee and moved the following resolution. The motion was seconded by Councilman Gillingham and approved by unanimous voice vote.

Councilman White advised that the concrete work is complete and the steel will be the next step for Borough Hall. He also advised that he misspoke with regards to the use of an unsafe structure ordinance. The International Residence Code New Jersey Edition was one resource used for the unsafe structure at Lyman Street. He also advised that the borough was in the process of developing an ordinance for property maintenance which will deal with issues such as dumpsters, overgrown landscaping, etc.

ORDINANCE NO. 671

AN ORDINANCE FIXING SALARY AND COMPENSATION OF CERTAIN OFFICERS, POSITIONS AND EMPLOYEES IN THE BOROUGH OF MANTOLOKING, OCEAN COUNTY, NEW JERSEY, TO BE KNOWN AS THE "MANTOLOKING BOROUGH SALARY ORDINANCE" **AND RESCINDING ORDINANCE 620**

D. RESOLUTION NO. 07/18/2017-06: MEMORIALIZING THE EXTENSION OF THE GRACE PERIOD TO SEPTEMBER 11, 2017, FOR THE AUGUST 1ST, 2017 TAX QUARTER DUE TO DELAY IN MAILING THE TAX BILLS

WHEREAS, State Statute provides that the Grace Period must be extended to allow for 25 days from the date of the mailing of the tax bills for payments of the August 1, 2017 tax quarter to be made without interest, and;

WHEREAS, The Tax Collector has set the last day to pay the August 1st, 2017 tax quarter at September 11, 2017, being the next business day after the 25 calendar days from the date the tax bills were mailed, and;

WHEREAS, The extension only applies to the August 1, 2017 tax quarter. The normal Borough grace period will apply to all other tax quarters on the bill.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Mantoloking, in the County of Ocean, State of New Jersey as follows:

1. The Governing Body of Mantoloking Borough memorializes the extension of the grace period to September 11, 2017 for the August 1, 2017 tax quarter and recognizes that the normal Borough grace period will apply to all other quarters on the tax bill.

<u>PUBLIC HEARING</u>: Mayor George C. Nebel opened the meeting to the public on Ordinance # 670. No comments were made.

E. <u>RESOLUTION NO. 07/18/2017-07: ADOPTION OF ORDINANCE NO. 670 TO EXCEED THE MUNICIPAL BUDGET APPROPRIATIONS LIMITS AND TO ESTABLISH A CAP BANK</u>

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit an increase in said budget to 2.50% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Mayor and Council of the Borough of Mantoloking in the County of Ocean finds it advisable and necessary to increase its CY 2017 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Mayor and Council hereby determined that a 3.5% increase in the budget for said year, amounting to \$138,532.42 of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Mayor and Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to the final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of Mantoloking in the County of Ocean, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2017 budget year, the final appropriations of the Borough of Mantoloking shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5%

amounting to \$138,532.42 and the CY 2017 municipal budget for the Borough of Mantoloking be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said director within 5 days after such adoption.
