- RESOLUTION NO. 06/22/2016-01: MINUTES OF PREVIOUS MEETINGS
 RESOLVED, the Mantoloking Borough Council approved the following minutes as printed and distributed.

8. PUBLIC WORKS COMMITTEE, Councilwoman Nelson presented reports from the Public Works Superintendent, Construction Official, and Land Use Officer and moved the following resolutions. The motion was seconded by Councilman Gillingham and approved by unanimous voice vote.

A. RESOLUTION NO. 06/22/206-02: CHANGE ORDER # 2 RESTORATION OF VARIOUS ROADWAYS (CONTRACT 2015-2)

WHEREAS, the Borough has entered into a Contract with Earle Asphalt Company, Inc. (Contract 2015-2); and

WHEREAS, the work proposed under contract Change Order # 2 is to extend the limits of work on Barnegat Lane near 916 Barnegat Lane north of the Bergen Avenue intersection to the municipal boundary line at the Borough of Bay Head as part of the Superstorm Sandy recovery efforts.

WHEREAS, during the contract drawing preparation stage, the northern section of Barnegat Lane was not included within the limits of work. Due to recent house recovery construction activity, the road condition has deteriorated as a result of multiple road openings and heavy construction vehicles /equipment loading.

WHEREAS, the Contractor has submitted a Change Order #2 in the sum of \$6,553.75; and WHEREAS, the Borough Engineer, Lawrence Plevier, P.E. (Mott MacDonald) has recommended change order #2 be approved, now, therefore, be it

RESOLVED, the Mantoloking Borough Council hereby approves the overall raise in contract price.

WHEREAS, the Borough has received donations from the citizens in support of the Borough Marine Patrol Program; and

The purpose of this ordinance is to authorize exceeding the 2016 Municipal

Budget Appropriation limits and to establish a cap bank.

ORDINANCE NO. 657

ORDINANCE TO EXCEED THE 2016 MUNICIPAL BUDGET APPROPRIATIONS LIMITS AND TO ESTABLISH A CAP BANK

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit an increase in said budget to 2.50% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Mayor and Council of the Borough of Mantoloking in the County of Ocean finds it advisable and necessary to increase its CY 2016 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Mayor and Council hereby determined that a 3.5% increase in the budget for said year, amounting to \$130,910.50 of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Mayor and Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to the final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of Mantoloking in the County of Ocean, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2016 budget year, the final appropriations of the Borough of Mantoloking shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5% amounting to \$130,910.50 and the CY 2016 municipal budget for the Borough of Mantoloking be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said director within 5 days after such adoption.

WHEREAS, Mathew D. Jessup, Esq. will be the attorney primarily responsible for this matter, other members of the firm will also provide services.

- 6. A Notice of this action shall be published in the official newspaper of the Borough.
- 11. <u>DUNE & BEACH RENOURISHMENT COMMITTEE</u>: Councilman Nelson presented the report of the Dune & Beach Renourishment Committee and Ocean County Block Grant Program.

Councilman Nelson discussed some DEP updates regarding easements and replenishment. Property owners are not cooperating with the DEP to allow access to their property. DEP has committed to go out to bid September 1, 2016. The project will extend from Brick to 1071 Ocean Avenue under the first bid process.
