PUBLIC COMMENT- On agenda items only- No comments were made.

MAYOR AND COUNCIL COMMENTS

Councilman Conti discussed the new Cash Management Plan. He further advised that he would provide another update at the next council meeting.

- After the 2008 financial crisis there was no reason to invest in liquid reserves
- The Borough floats 6 million dollars
- Now is a good time to invest in liquid reserves. The treasury is at 4.5 percent for short term investments
- Ocean First is ¾ of 1 percent which is substantially lower than the treasury.
- Council authorized investments up to 3 million (by resolution at a regular business meeting)
- Invest in Treasury Bills and NJ Cash Management which the auditor approved
- T-Bills 3 for \$500,000.00 each for short term investment 1, 2 and 3 months. Each month the Borough will have \$500,000.00 cash return
- Ocean First requested 4.5 million to keep in reserve due to payroll and armor car services they provide to the Borough that costs \$30,000.00
- April Yezzi, CFO went back to Ocean First and reported that the Borough is not comfortable with the reserve amount and would go out to bid if an agreement is not reached. She negotiated the 4.5 million to 3 million
