- Upon receipt of a Letter of Completeness from the Mantoloking Zoning Official (indicating that the homeowner has submitted all required documentation to the Borough relative to a specific variance request), the MEC will determine whether there are any environmental concerns.
- o If the MEC determines there are concerns, a letter outlining the specific recommendations will be drafted.
- o Upon approval of a majority of the MEC, this letter will be sent to:
 - 1. The Homeowner and/or Attorney (whoever is noted on the Letter of Completeness),
 - 2. The Planning Board Secretary to distribute to the Board, and
 - 3. The Borough Clerk to distribute to the Council.
