9. DUNE & BEACH COMMITTEE: Councilman Nelson presented the reports of the Dune & Beach Committee and Ocean County Block Grant Program and moved the following resolution.

PUBLIC HEARING - Mayor White opened the floor for comments on Ordinance 683

Lynn O'Mealia, 1304 Bay Avenue, asked about staffing on the weekends. Downer Avenue hours 10 a.m.-6 p.m. and Lyman Street 10 a.m.-5.00 p.m.

Mayor White- The Beach Budget is pretty big.

Chief Ferris- Beach Badge prices do not cover operation costs of Badge Checkers, 2 ATV's and equipment.

Bill Richardson, 981 East Avenue, explained that Bay Head applied for grants for handicapped access for all street ends. He further explained that it is a challenge for older people to get up on the beaches. Mayor White responded that Downer Avenue is the only handicap access. Chief Ferris advise Mr. Richardson that the Beach Staff can assist if needed.

Lynn O'Mealia, 1304 Bay Avenue, asked if we had a surplus from last year, Mayor White responded yes. Chief Financial Officer, April Yezzi, explained that it does not carry over. Councilman Amarante said it is less likely that we will have a surplus year based on additional lifeguards and ATV's.

John Tawgin, 1070 Barnegat Lane, wanted to know if the ATV's will be occupied by qualified people who can save lives, Chief Ferris responded yes.

Priscilla Hiby, 907 Barnegat Lane, hopes that next year the town would consider lifeguards for the center section of town.

Councilman Nelson explained that this is an evolution and we are trying to accommodate the residents, however, if we accommodated everyone it will cost a lot of money. Let's see how it goes this year. We should have a referendum every tax payer needs to have a say in it.

John Wesson, 1556 Runyon Lane, doesn't see what the problem is and said the town has done a great job to accommodate the residents.

Joanne Lygas, 970 Barnegat Lane, said this topic is very emotional for people. The most practical thing to do is to look at the numbers and geographically where are the majority of people are going to the beach.

Mayor White said outsourcing is something we will have to consider.

Jane White, 305 Old Bridge, said baby steps. She agrees with Councilman Nelson with taking one summer at a time and we will figure out.

ORDINANCE NO. 683

AN ORDINANCE OF THE BOROUGH OF MANTOLOKING, COUNTY OF OCEAN, STATE OF NEW JERSEY AMENDING THE BOROUGH CODE OF THE BOROUGH OF MANTOLOKING, SO AS TO AMEND CHAPTER 10, ENTITLED "BEACH REGULATIONS" SO AS TO REMOVE SUNSET PROVISION PERTAINING TO PROVIDING LIFEGUARDS AND ADJUST DATES AND FEES FOR BEACH BADGE SALES

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Mantoloking, County of Ocean, and State of New Jersey, as follows:

SECTION 1. Section 10-1.2 of Chapter 10 of the Borough Code of the Borough of Mantoloking, entitled, "Beach Regulations" is hereby amended and supplemented so as to read in its entirety as follows:

10-1.2 Findings, Declaration and Purpose.

This chapter is declared to be an exercise of the Police power in the interest of safety and welfare for the protection of persons and of property.

Access to the Atlantic Ocean beaches within and abutting the Borough of Mantoloking has, with increased population and improved transportation, become a matter of public concern. The character and quality of the access and use of the beach under the Public Trust Doctrine, as applied in New Jersey and proclaimed in various decisions of our Courts, necessitates that each community bordering on the Atlantic Ocean continuously review its policies, facilities, and procedures, together with an evaluation of the use and demand for use of beaches within the community by members of the public. The Borough is a small, fully developed, single-family, tranquil, noncommercial resort and year-round residential community on a very narrow portion of the barrier beach. Except for certain public access routes, the oceanfront at Mantoloking is privately owned, dedicated and restricted to residential use, up to the mean highwater line. These private property rights are, of course, subject to the rights of the public under the Public Trust Doctrine.

The Borough of Mantoloking recognizes its obligation to provide public access to the ocean under the Public Trust Doctrine. In furtherance of this obligation, the Borough will provide lifeguarding services at a limited number of locations for the summer of 2018, Persons utilizing the beach for bathing or swimming at unguarded areas or when lifeguards are not present do so at their own risk. Persons using the beach for surfing, kayaking or any other recreational use are strongly cautioned that they perform such activities at their own risk.

In order to evaluate and implement such participation by the Borough as is deemed appropriate, the Borough has acquired and will continue to acquire relevant data concerning the use of the beaches by requiring those who use the ocean beaches to apply for a seasonal beach badge. Beaches within the Borough are receiving increased use by members of the public who do not reside in the Borough and who may, therefore, not be familiar with local conditions and beach regulations. Further, the increased utilization of the beach by surfers and kayakers necessitates specific regulation of these activities. Surfing presents inherent risks to its participants and to others; surfers and bathers cannot safely coexist in close proximity to each other. It is, therefore, deemed necessary to control and regulate surfing so that, to the extent reasonably possible, the interests of all persons using the ocean may be reasonably accommodated.

The Borough of Mantoloking does, by the adoption of this chapter, express its continuing intention to establish and maintain a viable and balanced response to judicial determinations

concerning rights, both public and private, to the utilization and enjoyment of the ocean and bay beaches. The procedures, rules and regulations, as set forth and authorized herein, are deemed necessary and appropriate to provide for the health, safety and welfare of all concerned.

This chapter is not intended to be administered, enforced or interpreted in any manner that will expand public rights upon private property within the Borough, but rather to provide for access by the public pursuant to the Public Trust Doctrine and to exercise the Borough's general Police power over areas within its jurisdiction.

SECTION 2. Section 10-3 of Chapter 10 of the Borough Code of the Borough of Mantoloking, entitled, "Beach Regulations" is hereby amended and supplemented so as to read in its entirety as follows:

10-3 BEACH BADGES.

10-3.1 When Required.

Beach badges are required for persons **over** twelve (12) years of age, from **the third Saturday of June** to Labor Day of each year, inclusive, between the hours of 10:00 a.m. and **6:00** p.m.

SECTION 3. Section 10-3.2 of Chapter 10 of the Borough Code of the Borough of Mantoloking, entitled, "Beach Regulations" is hereby amended and supplemented so as to read in its entirety as follows:

10-3.2 Application and Fee.

Badges may be <u>purchased</u> at the municipal facilities on Downer Avenue, or such other location(s) as may be advertised, from 10:00 a.m. and **6:00 p.m.** Individuals desiring to purchase a seasonal beach badge shall be required to pay a fee of \$75.00 if said badge is purchased between April 1* and close of business on Memorial Day. If the seasonal beach badge is purchased after Memorial Day and on or before Labor Day, the cost of such seasonal beach badge shall be \$85.00. The beach badge shall be valid for the entire summer season of the year it is issued. Half season badges will be available starting the first Saturday in August for \$50.00. Daily badges will be sold for \$10.00 dollars per badge. No replacement badges will be issued without payment of the entire, then current, badge fee.

SECTION 4. Section 10-4.3 of Chapter 10 of the Borough Code of the Borough of Mantoloking, entitled, "Beach Regulations" is hereby amended and supplemented so as to read in its entirety as follows:

10-4.3 Beach Badges.

Display of Badge. All persons upon the beach and access ways or in or upon adjacent waters, as the case may be, shall wear and prominently display an approved current badge which has been registered in the name of that person, or in the name of that person's household.

Enforcement. All persons upon the beach and access ways or in or upon adjacent water during the hours of 10:00 a.m. to **6 p.m. commencing the third Saturday in June** through Labor Day shall, if not in immediate possession of an appropriate beach badge, promptly leave the beach upon the request of authorized enforcement personnel

SECTION 5. Section 10-4.18 of Chapter 10 of the Borough Code of the Borough of Mantoloking, entitled, "Beach Regulations" is hereby amended and supplemented so as to amend and replace subsection b. in its entirety so that it shall read follows:

b. In accordance with the terms of the "New Jersey Smoke Free Air Act," <u>N.J.S.A.</u> 26:3D-56 et seq., smoking of tobacco products and the use of electronic smoking devices is prohibited at all beaches and accessways within the Borough that are open and available to the public.

SECTION 6. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 7. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 8. This ordinance shall take effect after second reading and publication as required by law.

- 1. That the governing body does hereby appoint Colleen Malvasio as Code Enforcement Officer for the Borough of Mantoloking, March 19, 2019 through December 31, 2019, for which duties she shall receive no additional compensation.
- 2. That a certified copy of this resolution shall be forwarded to the Chief Financial Officer of the Borough of Mantoloking and Colleen Malvasio.

ORDINANCE NO. 684

AN ORDINANCE OF THE BOROUGH OF MANTOLOKING, COUNTY OF OCEAN, STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING THE BOROUGH CODE OF THE BOROUGH

OF MANTOLOKING, SO AS TO AMEND CHAPTER 30 ENTITLED "LAND USE REGULATIONS."

WHEREAS, the New Jersey Department of Environmental Protection requires all communities that contain tidal waters to provide for public access; and

WHEREAS, existing and future signage for public access is required; and

WHEREAS, installation and maintenance of signage associated with Public Access locations associated with the Borough's Municipal Public Access Plan is a requirement of N.J.A.C. 7:7-16.9(r).

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Mantoloking, County of Ocean, and State of New Jersey, as follows:

SECTION 1. The Municipal Code of the Borough of Mantoloking is hereby amended and supplemented so as to amend Chapter 30, entitled "Land Use Regulations," so as to amend § 30-6.14, entitled "Signs" so as to add subsection f. which shall be entitled "Public access signs" and which shall read as follows: f. Public Access Signs.

- i. The Chief of Police shall be responsible for the Borough's adherence to the signage requirements of the Municipal Public Access Plan.
- ii. The Public Works Manager shall be responsible for the placement and maintenance of the public access signage.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed. **SECTION 3**. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.

ROLL CALL VOTE:

Councilman Gillingham moved Ordinance 684. The motion was seconded by Councilman Amarante and approved by unanimous roll call vote.

ORDINANCE NO. 682

AN ORDINANCE OF THE BOROUGH OF MANTOLOKING, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE SALE OF CERTAIN LANDS OF THE BOROUGH OF MANTOLOKING NOT NEEDED FOR PUBLIC USE

WHEREAS, the Borough of Mantoloking is the owner of certain land located at Block 24, Lot 5.01 on the Tax Map of the Borough of Mantoloking, which nonconforming property is also known as 1030 Ocean Avenue; and

WHEREAS, pursuant to N.J.S.A 40A:12-13, said non-conforming property was offered to the contiguous property owners at the assessed value from two contiguous property owners and, as both were interested in purchasing same an auction was scheduled to be held between such contiguous property owners pursuant to N.J.S.A 40A:12-13. (5), and

WHEREAS, a public auction was duly advertised on December 28, 2018 and January 4, 2019; and

WHEREAS, the public auction was held on January 11, 2019 at 10:00 a.m. and there were two bidders in attendance; and

WHEREAS, the bidder, Whitney de Hosson bid a total of \$50,000.00 and remitted 10% of this amount, or \$5,000.00 by close of business on the day of the auction; and

WHEREAS, by the Borough Council formally accepted the bid submitted by Whitney de Hosson for Block 24, Lot 5.01 in the amount of \$50,000.00. by Resolution.

WHEREAS, the Borough is authorized to sell said land by public auction in accordance with <u>N.J.S.A.</u> 40A:12-13.2.

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Borough of Mantoloking, County of Ocean, State of New Jersey, as follows:

SECTION 1. The Borough Council hereby authorizes the sale pursuant to N.J.S.A. 40A:12-13 all of the Borough's right, title and interest in the land described as Block 24, Lot 5.01 on the Tax Map of the Borough of Mantoloking, which property is also known as 1030 Ocean Avenue, to Whitney de Hosson in the amount of \$50,000.00.

SECTION 2. That the Mayor and Borough Clerk are hereby authorized to execute any and all documents to transfer title to said property to Whitney de Hosson for the sum of \$50,000.00. Whitney de Hosson shall be responsible for the payment of the Borough's costs in conveying said property (i.e. attorneys' fees in the amount of \$550.00, publication costs in the approximate amount of \$250.00 and recording fees in the amount of \$110.00).

SECTION 3. This Ordinance shall be published twice in a newspaper approved for legal publications, once not less than seven (7) days prior to the public hearing thereof in accordance with law applicable to the adoption of ordinances generally, and a second time within five (5) days after adoption hereof, at which time it shall also be posted on the bulletin board in the Borough Municipal Building of the Borough of Mantoloking and remain so posted for at least twenty (20) days thereafter. Sworn proof of such publication shall be filed by the Borough Clerk with the Director of the State Division of Local Government Services in the Department of Community Affairs.

SECTION 4. The conveyance of shall be by standard municipal Bargain and Sale Deed without covenants of the Grantor, subject to any statement or facts which an accurate survey would show, subject to all covenants, conditions, easements, liens and restrictions of record, including the condition that the subject property be developed that the property only be used in accordance with the permitted and conditional uses allowed in the Residential Zone, as well as applicable ordinances of the Borough of Mantoloking shall be without obligation of the Borough of Mantoloking to provide access, public private, or any improvements thereon or thereto, with all sales being "as is" without any representation whatever as to character, quality or condition or otherwise, bidder being deemed to have inspected the premises bid upon and waived any objections to the conditions thereon.

SECTION 5. In the event the bidder should for any reason not pay the balance due as above provided, the Borough reserves the right to cancel the sale and retain the ten percent (10%) deposit as liquidated damages for non-performance. The sale is subject to the buyers review of existing title and the ability to accept or reject same in its sole discretion. In the event title is not insurable by the bidder at prevailing rates by a reputable title insurance company, bidder's sole remedy shall be to give written notice of cancellation of the bid to the Borough within ninety (90) days of the date of bid. The Borough shall refund the deposit, and there shall be no further obligation by either party to the other respecting said bid or any obligations created by the giving or acceptance of said bid.

SECTION 6. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 7. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 8. This ordinance shall take effect after second reading and publication as required by law.

ROLL CALL VOTE:

Councilman Nelson moved the Ordinance No. 682. The motion was seconded by Councilman Amarante and approved by roll unanimous roll call vote, Council President Gillingham abstained.

Councilman Batcha updated the public on the garbage schedule change on April 1st. He also stated that the Environmental Commission will be sending out a flyer in May to the residents. The Recycling Coach App is doing well. On Thursday April 18th the town will be receiving 1,000 seedlings through a grant and there is a need for volunteers to help distribute.

14. MAYOR AND COUNCIL COMMENTS

Councilman Rzemieniewski asked the Borough Attorney if she had an answer regarding partial assessments during construction. Borough Attorney, Robin LaBue, replied that the Tax Assessor has a detailed chart that is up to date and assessments go on the rolls quickly.

Councilman Nelson- Problems with Phone Books being thrown on curbs and driveways and remaining there for a period of time. An ordinance should be considered.

Mayor White read an email from Mr. and Mrs. Commett commending Police Department and Public Work's employees for responding so quickly regarding their plumbing problem.

Mayor White said the Army Corp will address the sink hole problem and dune grass will continue to be planted.

15. PUBLIC COMMENTS PERIOD

Bill Richardson, 981 Ocean Avenue, was looking for update on access to homeowners on the beach. Councilman Nelson said he talked to Robert Mainberger about the 3 fences, westward, top and bottom. All three should be kept up to collect sand and oceanfront residents can make a 4 foot access to the beach.

Linda Flihan, 1105 Barnegat Lane, asked why there were different colored flags in front of her house, Scott Hulse explained.

John Wesson, 1556 Runyon Lane, saw a healthy fox on Runyon Lane.

Councilman Nelson motioned to go into closed session. Councilman Amarante seconded the motion and was approved by unanimous voice vote at 6.26 p.m.
